The National Center for Youth Law's FosterEd Initiative improves the educational outcomes of students in the State's care. FosterEd collaborates with state and local agencies to ensure each student is supported by an educational champion and strengthened by an education team. FosterEd has directly served over 4,500 foster youth in California, Arizona, and Indiana. Foster youth in the program have overcome approximately 90% of identified educational challenges. FosterEd's policy efforts resulted in California becoming the first state to include foster youth as a distinct subgroup in its education accountability framework. As a result, Los Angeles Unified School District, the second largest school district in the country, developed a new \$9.9 million foster youth program.
