FosterEd collaborates with state and local agencies through demonstration sites to ensure that students are supported by an educational champion and strengthened by an education team. FosterEd currently operates as a statewide program in Arizona, and demonstration sites in California and New Mexico.

4b (Code:) (Expenses \$ 881,213. including grants of \$ 445,278.) (Revenue \$ 300,000.) Health and Info - This project will ensure California foster youth have access to critical reproductive and sexual health services through a multi-pronged approach that includes: state and county-level policy development and implementation support; development of new foster youth specific sexual health resources; litigation when necessary to enforce the reproductive rights of foster youth; and a public awareness campaign to raise awareness and spread best practices.

4c (Code:) (Expenses \$ 745,460. including grants of \$ 37,744.) (Revenue \$ 127,035.) NCYL's child welfare campaign places children and their well-being at the center of California's foster care system by institutionalizing a focus on the developmental needs of children and youth. We seek to shift the system such that youth can thrive, rather than merely survive. This project will improve the life outcomes of hundreds of thousands of children and youth in California's foster care system through complementary strategies: institutionalizing consistent collection and tracking of well-being indicators; incentivizing a focus on wellbeing; ensuring the availability of high-quality placements and mental health services; and supporting acceleration of reform and lifting up best practices.
